

### **MISSION**

### **Asset Forfeiture Report 2011**

Summary of asset forfeiture funds:

Federal asset forfeiture balance: \$ 16,533.82

State asset forfeiture balance: \$ 11,769.44

### In 2011 the department used asset forfeiture funds to purchase the following items:

- Used funds for confidential drug investigation purchases. (buy money)
- Uniforms
- Humvee preparation (aluminum roof, etc...)
- Emergency lights for vehicle
- Gun cleaning kits
- Digital cameras
- Surveillance cameras

The department expects federal and state asset forfeiture funds to continue to be awarded to the department in the upcoming year.
